ORDER

WHEREAS,

The bare minimum target of Civic Charges to be collected from the households in respect of each ward per month has been fixed vide Order No.DC/ICC/IMC-01/2017, dated 21st November, 2017 as per the survey conducted by the NGOs/SHGs in respect of their Municipal wards.

AND WHEREAS,

All the selected NGOs are directed to deposit this minimum amount of Civic Charges to be collected from the denizens to the Municipal Finance & Accounts Officer (MFO) by 7th of every month for timely payment of wages and conducting other activities.

AND WHEREAS,

It has been reported that the payment of wages to the labourers are being delayed due to long process and this may hamper the revamped door to door collection of garbage, within the Capital Complex.

AND WHEREAS,

This delay in payment of wages also acts a disincentive for collection of garbage charge by NGOs.

NOW THEREFORE,

It is hereby directed that the NGOs may deposit the amount of Civic Charges collected from the denizens to their concerned Assistant Engineers, IMC. The Assistant Engineers may disburse the salaries from the Civic Charge so collected to the NGOs after scrutinizing the bills and following codal formalities and the remaining amount along with details of salary disbursed be submitted to the Municipal Finance & Accounts Officer.

Further, the Municipal Finance & Accounts Officer is directed to submit monthly report of the same to the Office of the undersigned by 10th of every month personally without fail.
