Therefore, the bare minimum target of Civic Charges to be collected from the households in respect of each ward per month is hereby fixed as follows: -



All the selected NGOs are directed to deposit this minimum amount of Civic Charges to be collected from the denizens to the Municipal Finance & Accounts Officer (MFO) by 7<sup>th</sup> of every month for timely payment of wages and conducting other activities.

It is to be noted that the NGOs that deposit more than the minimum amount shall be given incentive up to the tune of 10% of the amount exceeding the minimum amount.

The Municipal Finance & Accounts Officer is directed to submit monthly report of the same to the Office of the undersigned by 10<sup>th</sup> of every month personally without fail.

All the NGOs are directed to enforce collection of Civic Charges with the help of Magistrates detailed vide Order No.DC/ICC/IMC-01/2017, dated 13<sup>th</sup> November, 2017.


